1. The Village of Mayville Council held an informational public hearing meeting at the Mayville Fire Hall, with Attorney Adam Flory present. Village President Valentine called the meeting to order at 7:01 pm
2. Pledge of Allegiance
3. Act 33 of 1951 Assessment overview

Village President Valentine, along with Attorney Adam Flory, discussed how Act 33 is an assessment that is evaluated yearly and based on taxable value, \$1.00 for every \$1,000 per mil for 3mil which brings about \$39,000.

The Act 33 assessment is specifically for Fire and Police Protection Equipment, maintenance, and fuel.

3. A petition was presented by Clare Fryers and Kimberlee Wingert Corl with the following wording: "By signing this petition you are making known that you object to the council voting at this time for the Proposed Special Assessment for Police and Fire Department Operations and for the Purchase, Maintenance and Operation of Equipment".

Adam Flory clarified that the petition did not request a Referendum, but rather stated Objections, which were required at the prior meeting, therefore the petition was invalid.

3. Public Comments  
Discussion of petition and clarification that assessment is only for 1 year.

Council/ Attorney Response - The petition lacked the necessary information and the only guarantee is our word.

Corrected verbiage - " This Village Council hereby determines that the annual assessment shall be collected in 2018. The Village Treasurer is hereby directed to spread such assessments on the Village's Tax rolls."
