Moved by Marlow and supported by Charette to allow the Sunflower Festival to be listed under the Village Insurance policy. Yeas-4. Nays-0.

### **Approval of Consent Agenda**

Moved by Charette and supported by Marlow that the following items contained in the consent agenda presented be approved and adopted: a) Approval of Regular Council Meeting Minutes: December 18, 2018; Approval of Committee of the Whole Minutes: January 8, 2019; Approval of Bills as presented. Moved by Atkinson and supported by Marlow to move funds raised through the ACT 33 Assessment into a 13 month Certificate of Deposit at Frankenmuth Credit Union at the interest rate of 2.5%. Yeas – 4. Nays – 0. Motion carried.

Moved by Marlow and supported by Atkinson to allow for the Drainage Easement to Mayville State Bank and accept the Quit Claim Deed from Mayville State Bank, for the additional land required to change the entrance to Ohmer Park to M-24. Yeas – 4. Nays – 0. Motioned carried.

Moved by Marlow and supported by Atkinson to contract with Spicer for the Right of Way to include Cedar and 6<sup>th</sup> Streets in ACT 51 Funding, at a cost of \$2000. Yeas – 4. Nays – 0. Motion carried.
