RESOLUTION ADOPTING THE VILLAGE OF MAYVILLE FIRST-AMENDED
COVID-19 PREPAREDNESS AND RESPONSE PLAN

WHEREAS, Governor Gretchen Whitmer has issued Executive Order Nos. 2020-77 and 2020-97, which require, in part, all governmental agencies to develop and adopt a COVID-19 Preparedness and Response Plan.

WHEREAS, the Village of Mayville Village Council desires to slow and stop the spread of COVID-19 and to save lives, minimize and mitigate damage, enhance the efficiency of efficacy of Village governmental operations, enhance emergency response operations and enhance and protect the lives of the Village's employees, citizens, residents and property owners.

WHEREAS, the Village of Mayville Village Council has determined that the adoption of the Village of Mayville COVID-19 First-Amended Preparedness and Response Plan will serve to effectuate the goal and desire described in the preceding paragraph.

NOW, THEREFORE, BE IT RESOLVED:

1. The Village of Mayville Village Council hereby fully adopts the Village of Mayville First-Amended COVID-19 Preparedness and Response Plan along with Exhibits A-D attached thereto.
2. Said Village of Mayville COVID-19 First-Amended Preparedness and Response Plan is subject to change at any time pursuant to the discretion of the Village Council. Said Plan shall remain in effect until further notice.

3. Consistent with the requirements of Executive Orders Nos. 2020-77 and 2020-97 and with the text of the Plan itself, said Plan shall be available for review, inspection and copying on the Village's website and at the Village's Governmental Offices.

4. All resolutions or parts of resolutions insofar as they conflict with the provisions hereof are rescinded to the extent of such conflict.
