At a meeting of the village of Mayville Village Council on Tuesday, September 19, 2023, at 7:00 P.m. in the Mayville Village Hall, 6104 Fulton Street, Mayville MI, the following resolution was presented by Steven Charette, Village President:

WHEREAS, the Village of Mayville employs a Village Manager, Clerk/Deputy Treasurer, Lien Certified Office Administrator, DPW Sewer Operator, a DPW Buildings and Maintenance Supervisor, DPW Water Operator, 2 DPW Workers, a Zoning Enforcement Officer, Interim Zoning Enforcement Officer, and a Chief of Police on a full time, part time, or irregular part time basis, and

**WHERAS**, the Village Council has approved the following Salaries and Wages for the remainder of the 2023 - 2024 fiscal year:

- 4. DPW Sewer Operator, \$20.99 Per Hour, 40 Hours Per Week
- 5. DPW Water Operator, \$25.00 Per Hour, 20 Hours Per Month
- 6. DPW Buildings and Maintenance Supervisor, \$20.07 Per Hour, 32 Hours Per Week
- 7. Village Manager, \$30 Per Hour, up to 25 Hours Per Week with No Benefits, Vacation, or Personal Time
- 8. Clerk/Deputy Treasurer, \$22.60 Per Hour, 18 Hours Per Week
- 9. Lien Certified Office Administrator, \$20.00 Per Hour to Start, 18 hours Per Week
- 10. DPW Worker #1, \$19.20 Per Hour, 24 hours Per Week
- 11. DPW Seasonal Full-Time Worker with CDL, \$19.50 per hour, 40 Hours Per Week during the Winter Season
